

## REMINDER: Requirement to offer a oneyear lease

A landlord is required to offer a one-year lease to the following:

- Any prospective tenant.
- Any current tenant, on either a lease or month-to-month tenancy, who is served with a rent increase notice (after the effective date of the Ordinance).

The one-year lease offered by the landlord must be on terms that are materially the same as the current lease in terms of duration, housing services and household composition, provided that such terms do not conflict with the stipulations of the Ordinance.
