# • FORM RP-100 – ATTACHMENT C • Tenant Request to Review Rent Increases

Contact us if you need translation services, or reasonable accommodations due to disabilities.

## **PURPOSE**

A tenant should file this form with the Rent Program to request that the Program staff review a rent increase notice to ensure that it complies with the City's rent ordinances and regulations.

### REQUIRED DOCUMENTS

In addition to filing this form, a tenant must file a copy of the rent increase notice that the landlord served on the tenant, as well as any attachments to the notice.

If the tenant does not have a copy of the rent increase notice, the tenant may submit alternative documentation to show the rent was increased, such as checks or bank statements, showing an increased rent payment.

#### **DEADLINE**

The required documents should be filed with the Rent Program at the tenant's earliest opportunity to ensure timely review. Rent Program staff may only "look back" three years from the time this request is filed to determine if previous notices of rent increases complied with the City's rent ordinances and regulations.

#### FOR YOUR INFORMATION

This form becomes a public record when submitted and is subject to disclosure under the California Public Records Act and the City of Alameda's Sunshine Ordinance.

#### **PROCEDURE**

A tenant may file this form by email, mail, fax, in person, or submit it online at <a href="https://www.alamedarentprogram.org">www.alamedarentprogram.org</a>. This "instructions page" does not need to be submitted.

Rent Program staff will contact you within two business days of receiving this form to confirm receipt and/or discuss next steps.
