- Use Attachment B when a unit is eligible for an exemption from the program fee. Documentation is required to substantiate the grounds for exemption.

PROCEDURE

After staff reviews the submission for compliance with the City's Rent Ordinance, staff will determine the Maximum Allowable Rent. Annually, staff will provide the determination of the Maximum Allowable Rent to Landlords and Tenants.
